c. Agency Reports

Dave Copeland – Sheila Harmes submitted, on behalf of WWJPB, a clean water fund application under the accelerated implementation pot of money BWSR had this year with Clean Water Funds. That particular pool had less funds and applications than they had funds available, so there is confidence the grant application will be approved. The BWSR board will discuss it at their December meeting; the packet is emailed out a week ahead of time. Additional discussion took place regarding cover crops. BWSR applied for a regional conservation partnership program with USDA and NRCS a year ago. The application was approved for \$25 million dollars in federal funds to be matched by \$25 million in state funds. BWSR has been working on the \$25 million dollar state fund match by putting RFP's out for the hiring of more SWCD staff to assist with soil health. Additionally, BWSR sent out soil health delivery grants to SWCD's and they're still working on an agreement with the federal government to potentially use the federal funds for cover crop contracts with producers. BWSR is still down one Board Conservationist position, which they hope to have filled by end of year. It is possible that Dave Copeland's work area will change depending on who is hired and their work area, so WWJPB may have a different BWSR Conservationist in the future.

Doug Cieslak_i– Introduced himself as the new Planning & Environmental Services Director and asked questions regarding cover crops. He reiterated that our Feedlot Officer Carly McGinty will be missed. He encouraged a safety share at the WWJPB meetings, inspired by his previous work history. Comprehensive Plan update process is underway.

d. Clean Water Fund Competitive Grant Submittal

Sheila Harmes shared a grant submittal, as previously introduced by Dave Copeland during the agency reports. The WWJPB and staff discussed applying for grants and grant writing.
